William B. Chapman (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Bank of Travelers Rest

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Thirty-Eight Thousand and

No/100-----DOLLARS (\$ 38,000.00),

with interest thereon from date at the rate of 8% per centum per annum, said principal and interest to be repaid: One (1) year from date, interest at the rate of 8%, payable semi-annually in advance

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns: "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Eastern side of the Old Rutherford Road, at the intersection with Highway No. 25, being shown as Lot No. 8 on plat of the property of W. M. Batson and Helen B. Dougherty, recorded in Plat Book "S" at page 105, and being more particularly described as follows:

BEGINNING at an iron pin on the Eastern side of Old Rutherford Road at joint front corner of Lots Nos. 8 and 9 and running thence with line of Lot No. 9 N. 86-10 E. 212.8 feet to pin at corner of Lot 14; thence with the rear line of said lot N. 3-50 W. to pin at corner of Lot No. 7; thence with the line of Lot 7 S. 86-10 W. 228.6 feet to pin on the Old Rutherford Road; thence with the Eastern side of said Road, S. 21-28 E. 52.4 feet to the point of beginning.

ALSO, ALL those pieces, parcels or lots of land situate, lying and being in the County of Greenville, State of South Carolina, on the Western side of Furman Hall Road and being known and designated as Lots Nos. 14, 15, 16 and 17 on plat of Property of W. M. Batson and Helen B. Dougherty recorded in the RMC Office for Greenville County in Plat Book S, Page 105, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Western side of Furman Hall Road at the joint front corner of Lots Nos. 14 and 13 and running thence along the joint line of said lots, S. 86-10 W. 131.6 feet to an iron pin; thence along the rear lines of Lots Nos. 14, 15, 16 and 17, N. 3-50 W. 200 feet to an iron pin at the joint rear corner of Lots Nos. 17 and 18; thence along the joint line of said lots, N. 86-10 E. 201.5 feet to an iron pin on the Western side of Cherrydale Drive; thence along said Drive, S. 25-55 E. 53.9 feet to an iron pin at the joint front corner of Lots Nos. 16 and 17; thence continuing along said Drive, S. 25-55 E. 4.2 feet to an iron pin at the Western intersection

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
