sealing and delivery of these presents, the receipt whereof is hereby acknowledged,
have granted, bargained, sold and released, and by these presents do grant, bargain,
sell and release unto the said mortgagee(s) the following described real property:

ALL That piece, parcel or lot of land in Greenville County, South Carolina known
and designated as Lot 86, Marshall Court in Casa Loma Estates, according to plat
recorded in the R. M. C. Office for Greenville County, South Carolina in Plat Book "S" at
page 65 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the West side of Marshall Court at the joint front
corner of Lots 87 and 86 and running thence along the West side of Marshall Court,
S. 12-20 E., 75 feet to an iron pin at the joint front corner of Lots 85 and 86;
thence along the joint line of Lots 85 and 86 S. 77-40 W. 181.1 feet to an iron pin;
thence along the line of Lot 90, N. 5-45 E., 33.9 feet to an iron pin; thence along
the line of Lot 88, N. 45-57 E., 82.5 feet to an iron pin at the joint corners of
