"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of <u>Greenville</u>, near the City of Greer, being known and designated as Lot No. 27 and the southerly one-half of Lot No. 28 as shown on a plat of Belmont Heights, recorded in Plat Book QQ at page 160 and 161 in the RMC Office for Greenville County and having, according to said plat, the following metes and bounds, to wit:
