TO ALL WHOM THESE PRESENTS MAY CONCERN: Joe J. and Esterlene B. Gilstrap

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty-four thousand-----and no/100ths -----DOLLARS

(\$ 24,000.00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 20 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Lockwood Avenue, and being known as designated as Lot No. 82 of Elletson Acres as shown on Plat thereof recorded in the RMC Office for Greenville County in Plat Book EE, page 161, and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Lockwood Avenue, at the joint front corner of Lots 82 and 83, and running thence along the joint line of said Lots N 85-06 E 241.5 feet to an iron pin at the rear corner of said Lots and in the line of Vaughan Estate; thence along Vaughan line S 29-15 E 79.5 feet to an iron pin; thence S 53-0 W 196 feet to an iron pin at the joint rear corner of Lots 81 and 82; thence along the joint line of said Lots 81 and 82 N 36-37 W 152.6 feet to an iron pin; thence still with the joint line of said lots N 81-37 W 28.5 feet to an iron pin on the eastern side of Lockwood Avenue, at the joint front corner of Lots 81 and 82; thence along Lockwood Avenue and following the curvature thereof, N 7-22 E 86.5 feet to the beginning corner.

LESS, however, all that lot of land being shown as a part of Lot 82 on a Plat recorded in Plat Book SS at page 129 and having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint line of Lots 82 and 83 nine (9) feet from the joint front corner of said Lots and running thence with said joint line S 83-39 E 11 feet to an iron pin; thence S 53-36 W 13.2 feet to an iron pin; thence with a curve, the chord of which is N 2-29 W 9 feet to the beginning corner.
