Credit Company (hereafter "Mortgagee") in the above Total of Payments and all future advances from Mortgagee to Mortgagor, the Maximum Outstanding at any given time not to exceed said amount stated above, hereby grants, bargains, sells, and releases to Mortgagee, its successors and assigns, the following described real estate

together with all improvements thereon situated in South Carolina, County of Greenville

All that piece, parcel or lot of land, being near the village of Mauldin, County and State aforesaid, containing one acre, more or less, and being known and designated as Lot No. 4 on Plat of Property of J. W. Clyde, as made by W. J. Riddle, Surveyor, in April, 1947, Said Lot of land begins in the center of a County Road on the Northeast boundary of J. W. Clyde's line and runs thence along the line of Clyde's property and other property lying in the east of his land N. 44-45 W. 209 feet to corner of Lot No. 5 of Clyde lands; thence along the line of Lot No. 5 S. 5-30 W. 209 feet to corner of Lot No. 3 on Clyde lands; thence along the dividing line between Lots Nos. 3 and 4 S. 44-45 E. 209 feet to corner in Center of a County Road; thence along center of said County Road N. 50-30 E. 209 feet to the beginning corner.

Any amount which Mortgagee may expend to discharge any tax, lien, assessment, obligation, covenant, insurance premium, prior mortgage or any charge whatsoever in connection with the above described real estate shall be an additional lien secured by this mortgage with interest at the highest lawful rate if not prohibited by law, and may be enforced and collected in the same manner as the debt hereby secured.

All obligations of Mortgagor to Mortgagee shall become due, at the option of Mortgagee, without notice or demand, upon any default.

Mortgagor agrees in case of foreclosure of this mortgage to pay a reasonable attorney's fee as determined by the court in which suit is filed and any court costs which shall be secured by this mortgage and included in judgment of foreclosure.

This mortgage shall extend, consolidate and renew any existing mortgage held by Mortgagee against Mortgagor on the above described real estate.
