ALL those pieces, parcels or lots of land situate, lying and being on the northern side of Woodbine Road in the City of Greenville, County of Greenville, State of South Carolina and known and designated as Lot No. 65 and portions of Lots Nos. 54 and 55 according to a plat of Northwood recorded in the R.M.C. Office for Greenville County in Plat Book J at Pages 102 and 103; also shown as the property of Walter Hamilton League by plat recorded in Plat Book 4U at Page 115; said lots having such metes and bounds as shown on said latter plat.
