WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 88 and the Southern one-half of Lot 89 on plat of Cleveland Forest Subdivision, plat of which is recorded in the RMC Office for Greenville County in Plat Book M. Page 137, and having according to said plat, the following courses and distances, to-wir:

BEGINNING at an iron pin on the Eastern side of Trails End Road joint front corner of Lots 87 and 88, and running thence with Trails End Road, N. 25-25 W. 90 feet to a point; thence in a new line through center of Lot 89, N. 64-35 E. 171.35 feet to an iron pin on the Western side of alley; thence with said alley, S. 26-35 E. 90 feet to an iron pin; thence S. 64-35 W. 173.2 feet to the point of beginning.
