(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto TRAVELERS REST FEDERAL SAVINGS AND LOAN ASSOCIATION OF Travelers Rest, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **TWELVE THOUSAND EIGHT HUNDRED & NO/100THS**

DOLLARS (\$12,800.00), with interest thereon from date at the rate of **EIGHT (8%)** per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of **Greenville**, in **O'Neal Township**, containing **5.95 acres** composed of three tracts and being described as follows:

BEGINNING at an iron pin in the center of the intersection of McElhaney (Frog Level) Road and another county road, and running thence along the center of McElhaney Road the following courses and distances, to-wit: N 71-30 W 136 feet to an iron pin; thence N 77-30 W 100 feet to an iron pin; thence N 82-20 W 100 feet to an iron pin; thence N 86-30 W 100 feet to an iron pin; thence along the center of the old road, N 79 E 100 feet to an iron pin; thence along the center of the old road, N 71-30 E 200 feet to an iron pin; thence N 16 E 814.3 feet to an iron pin; thence N 89-45 E 321 feet to an iron pin; thence S 8-30 W 440.5 feet to an iron pin; thence along the center of said county road, S 32-15 W 390 feet to an iron pin; thence S 48-15 W 215.2 feet to the point of beginning and being the same conveyed to us by Leonard A. and Betty Jo L.
