Day

to it on July 22, 1971 recorded in Mortgage Book 1199, page 484, public records of Greenville County, South Carolina, does hereby release and relinquish the lien of said mortgage insofar, and so far only, as the same covers and embraces the following described property:

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of S.C., being known and designated as Lot No. 3 on the Northern side of East North Street on a plat of Rowley Place of record in the Office of the RMC for Greenville County in Plat Book C, Page 5, less a strip taken from the front portion of said lot for the widening of East North Street, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northern side of the right-of-way of East North Street at the joint front corner of Lots 3 and 4, running thence along said right-of-way N. 76-30 E. 61 feet, 4 inches to the corner of Lot No. 2; running thence with the line of Lot No. 2, N. 21-45 W. 165 feet to a point on a 10-foot alley; running thence with said alley, S. 76-30 W. 61 feet, 4 inches to a pin at the rear corner of Lot 4; running thence with Lot 4, N. 21-45 E. 165 feet to the beginning corner.
