"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lots 3 and 4 on a Plat of Terrace Acres, by Carolina Engineering and Surveying, recorded in the R.M.C. Office for Greenville County in Plat Book 000 at Page 126 and being more fully described according to the metes and bounds of said Plat as follows:
