NOW, KNOW ALL, MRN, That the Morigagor, in consideration of the aforestid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagor at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant; bargain, sell and release unto the Mortgagoe, its successors and hasigos.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, affirmed bying and being in the State of Bouth Carollia, County of Greenville, on the Easterly side of Holmes Drive, shown and designated as Lot No. 163 on Plat of Property of Central Development Corporation recorded in the RMC Office for Greenville County in Plat Book, BB", at Pages 22 and 23, and having the following meter and bounds, to with

BEGINNING at an Iron pin on the Easterly side of Holmes Drive, joint front corner of Lots Nos. 102 and 103, and running thence with the joint line of said lots, 5. 72-14 E., 200 feet to an Iron pin, thence with line of Lot No. 105, N. 26-10 W., 119.6 feet to an Iron pin at the joint rear corner of Lots Nos. 103, 104 and 105, thence with line of Lot No. 104, N. 72-39 W., 122.7 feet to an Iron pin on the Easterly side of Holmes Drive; thence with the Easterly side of Holmes Drive, 5. 14-08 W., 85 feet to the point of BEGINNING.

In addition to and together with the monthly payments of principal and interest under the terms of the note secured hereby, the mortgager promises to pay to the mortgages for the term of the guaranty policy the sum of 1/48th of % of the original amount of this loan in payment of the mortgage guaranty insurance covering this loan and on his fallure to pay it, the mortgages may advance it for the mortgager's amount and callect it as part of the debt secured by the martgage.
