"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Creighton Street, near the City of Greenville, being known and designated as Lot No. 255. Section 6, Sheet One, of a subdivision known as Colonial Hills, as shown on a plat prepared by Piedmont Engineers & Architects dated March 21, 1968, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book WWW at Page 12, and having according to said plat the following metes and bounds, to-wit:
