

MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

Dollare as evidenced by Mortgagor's promissory note of even date herewith, which note a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate inder certain

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of Ninety-Three

and 94/100—

1 Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on impaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable

20 years after date; and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereinder shall be past due and unpaid for a period of thirty days, or if there shall be any lathere to comply with and abide by any Byklaws or the Charter of the Mortgage, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereoff become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three-Dollars (\$3.00) so the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Gantt Township, on the northern side of Milton Drive, being shown and designated as Lot 72 on a Plat of Sylvan Hills; recorded in the R. M. C. Office for Greenville County, in Plat Book "S", at Page 103, and having, according to said Plat, the following metes and bounds, to-wit:

Beginning at a point on the northern side of Milton Drive, joint front corner of Lots. 71 and 72 and running thence along the common line of said Lots N. 5-36 W. 150 feet to a point, joint rear corner of Lots 71 and 72; thence along the rear line of Lot. 81, N. 84-24 E. 70 feet to a point, joint rear corner of Lots 73 and 73; thence along the common line of Lots 72 and 73; S. 5-36 E. 150 feet to a point on the north side of Milton Drive, joint front corner of Lots 72 and 73; thence along the north side of said Drive, S. 84-24 W. 70 feet to the point of beginning.
