

That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagoe to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$5.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted Bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, purcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the state of South Carolina, County of

ALL that piece, parcel or lot of land situate, lying and being on the western side of Saint Mark Road near the City of Greenville, in the County of Greenville, State of South Carolina and known and designated as Lot No. 1 of a subdivision of property of Jack E. Gilliam, Jr., plat of which is recorded in the R.M.C. Office for Greenville County in Plat Book 4F at Page 30 and according to said plat has the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Saint Mark Road at the joint front corner of Lots Nos. I and 2 and running thence with the joint line of said lots S. 68-35 W., 195.4 feet to an iron pin; running thence S. 21-25 E., 100 feet to an iron pin at the joint rear corner of Lot No. 1 and property now or formerly of Virginia A. Joines; running thence with the joint line of said property N. 68-35 E., 195.4 feet to an iron pin on the western side of Saint Mark Road; running thence with the western side of said road N. 21-27 W., 100 feet to an iron pin, point of beginning.
