(heremafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indepted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, CREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty Thousand

(\$20,400.00), as evidenced by the Mortgagor's note of even date, libraring interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which years after the date hereof sunless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgague for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagoe on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagea at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted hargained, sold and released, and by these presents does grant, bargain, soll and release unto the Mortgageo, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon. situate, lying and being in the State of South Carolina, County of Greenville, on the southeastern sfile of Lanewood Drive and being known and designated as Lots 60 and 61 on a plat of PINE FOREST Subdivision, plat of which is recorded in the RMC Office for Green ille County in Plat Book QQ at plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the southeastern side of Lanewood Drive at the joint front-corner of Lots 61 and 62 and running thence with the common line of said Lots 5.26-30 E. 138 feet to an Iron pin at the joint rear corner of said Lots; thence N.63-30 E. 200 feet to an iron pin on the western side of Dalegrove Drive, thence with said Drive N. 26-30 W. 113 feet to an Iron pin at the corner of the intersection of Dalegrove Drive and Lanewood Drive; thence with the curve of the intersection, the chord of which is N.71-30 W. 35.3 feet to an iron pin on Lanewood Drive; thence with Lanewood Drive S.63-30 W. 175 feet to the point of beginning.

In addition to and together with the monthly payments of principal and interest under the terms of the note secured hereby, the mortgagor promises to pay to the mortgagee for the term of the guaranty policy the sum of 1/48th of 1% of the, original amount of this loan in payment of the mortgage guaranty insurance covering this loan and on his failure to pay it, the mortgage may advance it for the mortgagor's amount and collect it as part of the debt secured by the mortgage.

The mortgagors agree that after the expiration of ten years from the date hereof, the mortgagee may at its option apply for mortgage insurance for an additional period of five years with the mortgage insurance company insuring this loan, and the mortgagor agrees to pay to the mortgages as premium for such insurance one-half of 1% of the principal balance then existing.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fix tures and equipment, other than the usual household furniture, be considered a part of the real estate.
