

It is hereby agreed, that should any default be made in the payment of interest on said mortgage, and such interest remains unpaid and in arrears for ten days, or should any suit be commenced to foreclose said title mortgages, then the amount secured by this mortgage and the accompanying note shall become due and payable at any time thereafter at the option of the owner or holder of this mortgage.

It is further agreed, generally, that said mortgagor may, at his election, advance and pay any and all sums of money that in its judgment may be necessary to perfect title of said mortgaged premises or to preserve or defend the security intended to be given by this mortgage to advance and pay any and all installments of principal or interest on any and all prior mortgage items and any and all sums of money so advanced and paid, shall bear interest at the rate of which was originally contracted for in this instrument, and they hereby are made part of the mortgage debt herein secured. The mortgagors hereby expressly agree to pay all and singularly the sum of money together with said interest so advanced or paid by the holder hereof.

TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular the said Premises unto the said Security Finance Corporation of Spartanburg, 116

heirs and assigns forever.

AND I do hereby bind myself and my heirs, executors and administrators, to procure and execute any further necessary assurances of title to the said premises, the title to which is unencumbered, and also to warrant and forever defend all and singular the said Premises unto the said mortgagee Security Finance Corporation of persons, Spartanburg and assigns, from and against all, and their heirs, executors and administrators

and all persons lawfully claiming, or to claim the same or any part thereof.

AND IT IS AGREED, by and between the parties hereto, that the said mortgagor, their heirs, executors, or administrators, shall keep the buildings erected, or to be erected, on said premises, insured against loss or damage by fire, for the benefit of the said mortgagee, for an amount not less than Seven Thousand Two Hundred Ninety-six and NO/100 Dollars, in such company as shall be approved by the said mortgagee, and shall deliver the policy to the said mortgagee, and in default thereof,

the said mortgagee, Security Finance Corporation of Spartanburg, or assigns, may effect such insurance and reimburse themselves under this mortgage for the expense thereof, with interest thereon, from the date of its payment. And it is further agreed, in the event of other insurance and contribution between the insurers, that the said mortgagee, Security Finance Corporation of Spartanburg, or assigns, shall be entitled to receive from the aggregate of the insurance money to be paid, a sum equal to the amount of the debt secured by this mortgage.

AND IT IS AGREED, by and between the said parties, that if the said mortgagor, their heirs, executors, or administrators, shall fail to pay all taxes and assessments upon the said premises when the same shall first become payable,

then the said mortgagee, Security Finance Corporation of Spartanburg, or assigns, may cause the same to be paid, together with all penalties and costs accrued thereon, and reimburse themselves under this mortgage for the same to be paid, with interest thereon, from the date of such payment.

AND IT IS AGREED, by and between the said parties, that upon any default being made in the payment of the interest on the said Note, or of the insurance premiums, or of the taxes, or of the assessments hereinabove mentioned, when the same shall severally first become payable, or in any other of the provisions of this mortgage, that then the entire amount of the debt secured, or intended to be secured hereby, shall forthwith become due, at the option of the said mortgagee, ad aforesaid, or assigns, although the period for the payment of the said debt may not then have expired.

AND IT IS AGREED, That if the holder of the Note aforesaid hereby is compelled to pay any taxes upon the debt represented by said note, or by this mortgage, then, and in that event, unless the said taxes are paid by some party other than the said holder, that then the entire amount of the debt secured, or intended to be secured, shall forthwith become due at the option of the said mortgagee, ad aforesaid, or assigns, although the period for its payment may not then have expired.

AND IT IS AGREED, by and between the said parties, that should legal proceedings be instituted for the collection of the debt secured hereby, then and in that event, the said mortgagee, ad aforesaid, or assigns, shall have the right to have a receiver appointed in the name of the said mortgagee, ad aforesaid, receiver, with power to forthwith foreclose the said mortgage, and to sell the same, and to apply the proceeds of the sale, after payment of all expenses of sale, to the payment of the debt secured hereby.
