TO ALL WHOM THESE PRESENTS MAY CONCERN: PETER D. BYLENKA

(hereinafter referred to as Mortgagor) SEND(S) GREETING

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Ninety One Thousand and No/100 ----- DOLLARS

(\$ 91,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 20 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, hereinafter described thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known as 1.6 acres, more or less, as shown on a Plat of "Property of Peter Bylenka, prepared by Dalton and Nevas, Engineers, dated July, 1973, and having according to said Plat, the following metes and bounds:

BEGINNING at a nail and cap on the northeastern edge of Pelham Road, at the intersection of Butler Springs Road, and running thence along the southwestern edge of Butler Springs Road, S. 70-10 E. 629.5 feet to an iron pin; thence along the line of property of Allan J. Inglesby, 31-28 W. 221.8 feet to an iron pin on the northeastern edge of Pelham Road; thence along the northeastern edge of Pelham Road, N. 53-32 W. 589.5 feet to the beginning corner.

Together with all and singular the rights, tenures, hereditaments, and appurtenances to the said premises in any way incident or appertaining, and all of the rents, issues, and profits which may or shall be had thereon, and including all heating, plumbing, and lighting fixtures and any other equipment or improvements or fixtures attached, connected, or fitted thereto in any manner; it being the intention of the Mortgagor that the said premises, fixtures and equipment, other than the usual household furniture, furnishings, fixtures or other contents of the premises,
