All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, containing 1,31 acres, more or less, as shown on a plat of property of John D. Batson and Dianne Batson prepared by John's Engineering Service on June 15, 1972, and having according thereto the following courses and distances to-wit:

BEGINNING at an iron pin on the Northwest side of Club View Drive, located 647.7 feet Northeast of Traynham Boulevard, and running thence N. 73-02 W. 300 feet to an iron pin; thence N. 41-42 E. 336 feet to an iron pin; thence S. 23-34 E. 300 feet to an iron pin; thence along said Drive S. 41-42 W. 85 feet to the point of beginning.
