

MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagoe) in the full and just sum of

Fifteen Thousand and No/100----- (15,000.00

Dollars, as evidenced by Mortgagor's promissory note of even date herewith, which note does not contain a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain

conditions), said note to he repaid with interest as the rate or rates therein specified in installments of One Hundred Ten

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thefeunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any hy-haws or the Charter of the Mortgage, or any stipulations set out in this mortgage, the whole amount due thereunder shall at the option of the holder thereof, become, immediately due and payablo, and said holder shall have the right to institute any proceedings upon said bute aim any culiaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indobted to the Mortgagoe for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW. KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor, in consideration of the sum of Three Dullars (\$3,00) to the Mortgagor in hand well-and truly paid by the Mortgagor, at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released of those presents does grant, bargain, sell and interest unto the Mortgagor, its successors and assigns, the following described grant the section place.

All that certain piece, parcel, or lot of land, with all improved that thereon, or harmiter to be constructed thereon, and being in the State of South Caroling. County of Greenville, in the City of Greenville, on the southeastern side of Wedgewood Drive, being shown and designated as Lot No. 17 on a plat of NORTH MEADOW HEIGHTS made by Pledmont Engineering Service dated February 22, 1951, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book W, at page 183, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southeastern side of Wedgewood Drive at the joint front corner of Lots Nos. 16 and 17 and running themes along the Southeastern side of Wedgewood Drive N. 62-14 E. 75 feet to an iron pin at the joint front corners of Lots Nos. 17 and 181 themes along the common line of said lots S. 27-46 E. 140 feet to an iron pinthence S. 58-17 W. 76.2 feet to an iron pin at the corner of Lot 16; thence along the line of said lot N. 27-46 W. 145 feet to an iron pinthe beginning corner.
