(hereinafter referred to as Mortgagor) SEND(S) GREETING:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of **Greenville**, on the Southwest side of a County Road near Travelers Rest, in Oneal Township, and having the following courses and distances, to-wit: Beginning at a Nail & Cap in said road and running thence S.89-09 W.200 feet to an Iron Pin, thence N.30-51 W.100 feet to an Iron Pin, thence N.59-09 E. 200 feet to a Spike in said road, thence with said road S.30-51 E. 100 feet to the beginning point. This being the same property which was conveyed to mortgagor herein by Betty Lucille Bates Bowers by deed recorded in the R. M. C. Office for said County in Deed Book 949, page 485.
