That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Grove Township, situate, lying and being on the western side of S. C. Highway 20, about 2 miles north of Piedmont, S. C., and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern corner of the intersection of S. C. Highway 20 and Golden Grove Circle and running thence along S. C. Highway 20 S. 0-30 E. 168.0 feet to an iron pin; thence S. 73-30 W. 380 feet to an iron pin; thence N. 25-06 E. 282.6 feet to an iron pin on Golden Grove Circle; thence along Golden Grove Circle S. 88-50 E. 157.3 feet to the beginning .
