NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the County of Greenville, State of South Carolina, and being known and designated as Lot No. 1 as shown on a plat entitled "Section One, Jenkins Estates, Southwest", dated February, 1972, prepared by C. O. Riddle, which plat is of record in the RMC Office for Greenville County in Plat Book 4-M, Page 197, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on the edge of Fork Shoals Road, joint front corner of Lot 1 and C. D. Jenkins, Jr. property; running thence S 27-00 E 170 feet to point on edge of Fork Shoals Road, joint front corner of Lots 1 and 2; running thence S 63-36 W 256.8 feet to point; running thence N 26-24 W 170 feet to point; running thence N 63-36 E 255 Feet to point of beginning.
