

MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

ROBERT GOBBLE, JR., and NANCY K. GOBBLE,
(hereinaster reserred to as Mortgagor) (SEND(S) GREETING:
WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF CREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of
Twenty-three Thousand Seven Hundred and No/100(\$ 23,700.00
Dollars, as evidenced by Mortgagor's promissory note of even date herewith, which notedoes_not_contain_ a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain
conditions), said note to be repaid with interest as the rate or rates therein specified in installments of
One Hundred Seventy-three and 91/100(\$173.91) Dollars each on the first day of each of interest, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not soone
paid, to be due and payable years after date; and
WHEREAS and make final and a state of the st

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and shide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW. KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the southeastern corner of Circle Drive and Brooks Road, and being known and designated as Lot No. 137 on Plat No. 4 of addition to Greenbrier, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book QQ, at Page 130, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of Circle Drive, at the joint corner of Lots Nos. 137 and 138, and running thence along the joint line of said lots, S 44-20 W, 190 ft. to an iron pin; thence N 45-40 W, 145 ft. to an iron pin on the southern side of Brooks Road; thence along said Road, N 54-45 E, 173.1 ft. to an iron pin; thence with the curve of the intersection of said road and Circle Drive, the chord of which is S 85-28 E 30.7 ft., to an iron pin; thence along the southwestern side of Circle Drive, S 45-40 E, 90 ft. to the point of beginning.
