MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

STUBBLEFIELD BUILDERS, INC.

(hereinaster referred to as Mortgagor) (SEND(S) GREETINGS:

WHEREAS, the Moitgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

TWENTY-FOUR THOUSAND ---- (\$ 24,000.00

Dollars, as evidenced by Mortgagor's promissory note of even date herewith, which note Contains

a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain conditions), said note to be repaid with interest as the rate or rates therein specified in installments of ONE HUNDRED NINETY

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagoe for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW. KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oneal Township, in the Washington Baptist Church Community, about six miles north of Greer, containing 11.08 acres, more or less, as shown on a plat entitled "Property of J. R. Pender Estate; dated uctoher 23, 1972, by H. S. Brockman, Surveyor, and having according to said plat the following metes and bounds, to-wit:

Beginning at a nail in the center of old Highway No. 14 at its intersection with Gap Creek Road and a paved count, road, and running theore with the paved county road No. 39-10 E. 531.5 feet to a nail (iron pin back at 26 feet); thence continuin, with said road No. 39-10 E. 186 feet to a nail; thence continuing said road No. 37-30 E. 326.5 feet to a nail in said paved county road; thence with another paved county road No. 22-15 Word 423.5 feet to a nail (iron pin back at 25 feet); thence South 42-25 word 1024.7 feet to a nail in the center of old Highway No. 14 (iron pin back at 14.8 feet); thence along and with old Highway No. 14, South 27-00 E. 578 feet to the point of beginning.
