

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any Jadure to comply with and abide by any By-Laws or the Charter of the Mortgagge, or any stipulations set out in this mortgage, the whole amount due thereunder shall at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW. KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagoe to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, burgained, sold, and released, and by these presents does grant, burgain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northeasterly side of White Horse Road, S. C. Highway 250, near the City of Greenville, S. C., containing 4.42 agres and having, according to a plat entitled "Property of Claude F. Cato" dated February, 1948, prepared by Dalton & Neves and recorded in the RMC Office for Greenville County, S. C., in Plat Book 0000., page 2, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeasterly side of White Horse Road, S. C. Highway 250, said pin being the joint front corner of property of Lloyd R. Cato and Graceland Cemetery and running thence N 64-34 E 462.9 feet to an iron pin, said pin being the joint corner of property of Lloyd R. Cato and property now or former by belonging to Graceland Cemetery and Beth Israel Cemetery Association; thence N 26-35 W 442.4 feet to an iron pin on the southerly side of Earle Drive; thence with the southerly side of Earle Drive S 62-44 W 387.0 feet to an iron pin; thence on a curve with the intersection of White Horse Road, S. C. Highway 250, and Earle Drive, the chord of which is S 39-11 W 50 feet to an iron pin on the northeasterly side of White Horse Road, S. C. Highway 250; thence with the northeasterly side of White Horse Road, S. C. Highway 250, S 22-21 E 410 feet to an iron pin, the point of beginning.
