R. ALVIN HAWKINS

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty Three Thousand and No/100ths-----DOLLARS

(\$ 23,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is twenty-five years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 7 on plat entitled "Addition to Section No. 2, Belle Terre Acres, Section No. 1" by Piedmont Engineers and Architects, dated November 28, 1969, and recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book 4F at page 8, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northern side of Green Leaf Lane and running thence with said Lane N. 71-28 W. 105 feet; thence N. 68-18 W. 100 feet to an iron pin; thence N. 60-55 W. 100 feet to an iron pin at the joint front corner of Lots No. 6 and 7; thence leaving said Lane and running with the line of Lot No. 6, N. 24-56 W. 279.5 feet to an iron pin at the joint rear corner of Lots No. 6 and 7; thence S. 68-03 E. 66.5 feet to an iron pin; thence S. 76-45 E. 178.5 feet to an iron pin; thence S. 13-25 W. 315.9 feet to the point of beginning.
