All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, being known as Lot 24 of a subdivision known as Terrydale (also known as Henderson Forest), and being located on Verdia Circle (also known as Dahlglen Avenue) and having according to a plat of Lot 24 recorded in Plat Book 4 N at page 17, the following metes and bounds, to-wit:

Beginning at an iron pin on the right-of-way of Dahlglen Avenue and running thence S. 10-55 W. 186.1 feet to property now or formerly of Toy H.
