WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, containing 10.0 acres, more or less, near Rutherford Road - Old U. S. Highway No. 29 being known and designated as Tract B as shown on Plat entitled "Property of Brent Corporation" dated November 28, 1972, prepared by Campbell and Clarkson Surveyors, Inc., and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint corner of Tracts A and B as shown on the plat referred to hereinabove, said iron pin being N.17-35 E. 526.77 feet from the Northern side of Rutherford Road - Old U. S. Highway No. 29, and running thence N.17-35 E. 461.41 feet to an iron pin; thence S.72-25E. 944.06 feet to an iron pin; thence S.17-35 W. 461.41 feet to an iron pin; thence N.72-25 W. 944.06 feet to the point of beginning.
