That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagoe to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northwestern side of Waterloo Circle, being known and designated as Lot No. 12, as shown on a Plat of Boiling Springs Estates, recorded in the R. M. C. Office for Greenville County, in Plat Book "YY" at Pages 14 and 15, and having, according to said Plat, the following metes and bounds,

BEGINNING at an iron pin on the northwestern side of Waterloo Circle, at the joint front corner of Lots 12 and 13, and running thence with the common line of Lots 12 and 13, N. 22-17 W. 240 feet to an iron pin; thence running N. 74-02 E. 211.7 feet to an iron pin at the joint rear corner of Lots 11 and 12; thence with the common line of said Lots, S. 20-12 E. 223.2 feet to an iron pin on the northwestern side of Waterloo Circle; thence with the line of said Circle, S. 69-48 W. 177.4 feet to an iron pin; thence continuing with the line of said Circle, S. 67-48 W. 25 feet to the point of beginning.
