

MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of
Thirty Thousand and No/100(\$30,000.00
Dollars, as evidenced by Mortgagor's promissory note of even date herewith, which note does not contain a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain
conditions), said note to be repaid with interest as the rate or rates therein specified in installments of . Two Hundred
Twenty and 13/100

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgage, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagoe for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW. KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon or bereafter to be constructed thereon situate lying and being in the State of South Carolina, County of Greenville, situate on the northwest side of Terrain Drive near the City of Greenville, being shown as Lot 20 on Plat of Fairway Acres, recorded in the RMC Office for Greenville, S. C. in Plat Book 4-F, Page 43 and having, according to said plat, the following metes and bounds; to-wit:

BEGINNING at an iron pin on the northwest side of Terrain Drive at the joint corner of Lots 20 and 21 and runs thence along the northwest side of Terrain Drive: S. 56-0 W. 135 feet to an iron pin; thence along the line of Lots 18 and 19 N. 39-20 W. 219.5 feet to an iron pin; thence N. 63-08 E. 155 feet to an iron pin; thence with the line of Lot 21 S. 34-22 E. 202.1 feet to the beginning corner.
