WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as

Lot No. 85, on plat of Holly Springs, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 4R, at Page 54, and having, according to said plat, the following courses and distances, to-wit:

BEGINNING at a point on the edge of Holly Lane, joint front corner of Lots Nos. 84 and 85, and running thence, N. 87-41 E. 85 feet to a point; thence, S. 40-32 E. 31 feet to a point on the edge of Brookbend Road; thence with said road, S. 11-14 W. 130 feet to a point, joint corner of Lots Nos. 85 and 86; thence with the common line of said lots, S. 89-00 W. 86.9 feet to a point; thence, N. 2-43 E. 149.2 feet to a point on the edge of Holly Lane, the point of beginning.

In additiona to and together with the monthly payments of principal and interest under the terms of the note secured hereby, the mortgagor promises to pay to the mortgagee for the term of the guaranty policy the sum of 1/48th of 1% of the original amount of this loan in payment of the mortgage guaranty insurance covering this loan and on his failure to pay it, the mortgagee may advance it for the mortgagor's amount and collect it as part of the debt secured by the mortgage. The mortgagors agree that after the expiration of ten years from the date hereof, the mortgagee may at its option apply for mortgage insurance for an additional period of five years with the mortgage insurance company insuring this loan, and the mortgagor agrees to pay to the mortgagee as premium for such insurance one half of 1% of the principal balance then existing.
