"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southern side of Alternate U.S. Highway 123 - New Easley Highway, and being known and designated as part of Tract 3 on survey for Salvage Sales Co., recorded in the RMC Office for Greenville County, South Carolina, in Plat Book $4\sqrt{}$, at Page 40, and having, according to said Plat, the following metes and bounds:

BEGINNING at a point on the southern edge of said highway, and running thence S. 4-40 N. 300 feet to a point; thence along a line of part of Tract 3, N. 85-20 W. 50 feet to a point; thence N. 4-40 E. 300 feet to the southern edge of Alternace U.S. Highway 123 - New Easley Highway; thence along the edge of said Highway, S. 85-20 E. 50 feet to the beginning
