NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, having the following metes and bounds, to wit:

BEGINNING at an iron pin on a private road leading from the Old Spartanburg Road at the joint front corner of property of L. A. Cunningham, and property now or formerly of Gibson Brothers, Inc. and F. M. Gibson and other property of the mortgagor herein and running thence with the line of other property of the mortgagor herein, N. 83-57 E. 187.8 ft. to an iron pin; thence S. 01-57 W. 124.5 ft. to an iron pin; thence S. 83.57 W. 187.8 ft. more or less to a point in the edge of private road leading from Old Spartanburg Road; thence N. 02-39 E. 124.5 ft. more or less to the point of beginning.
