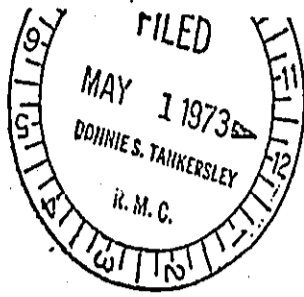

Domestic Loans of Greenville, Inc. the following described property being real estate situate in the County of Greenville, S.C. State of South Carolina

All that lot of land together with buildings and improvements, lying on the Northern side of Oak Street in Greenville, County, South Carolina, being shown as Lot No. # 2 Block C. On Plat of Woodville Heights, recorded in the RMC I Office for Greenville County, South Carolina, in Plat Book L. Pages 14 and 15 and Having according to said plat the following notes and bounds, to wit:

Beginning at the iron pin on the Northern side of Oak Street at joint front corners of Lot 2 and 3 Block C. and running thence N. 16-50 W. 175 Feet to an iron pin. thence S. 73-10 W. 80 feet to an iron pin; thence S. 23-E 176.3 feet to an iron pin or oak St. thence along the Northern side of Oak Street N. 73-10 E 60 Feet to an iron Pin, to the beginning corner.
