TO ALL WHOM THESE PRESENTS MAY CONCERN: Rose Frisbie Ridgeway, individually and Nathan A. Ridgeway, Jr. and Walter Ragsdale, as Trustees under Will of Nathan (hereinafter referred to as Mortgagor) SEND(S) GREETING: A. Ridgeway, deceased

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Three Thousand Three Hundred and No/100ths-----DOLLARS

(\$ 3,300.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 7 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and lying and being on the west side of Afton Avenue and being known and designated as Lot No. 50 according to a plat of Alta Vista made by R. E. Dalton and recorded in the RMC Office for Greenville County in Plat Book G at Page 20 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a stake on the west side of Afton Avenue 350.2 feet north of Crescent Avenue (formerly Oliver Street) at the corner of Lot 51 and running thence with the line of said Lot, N. 85-40 W. 160 feet to a stake in the line of Lot 39; thence with the line of said Lot, N. 4-15 E. 60 feet to a stake at the corner of Lot 49; thence with the line of said Lot, S. 85-40 E. 160 feet to a stake on Afton Avenue; thence with the west side of Afton Avenue, S. 4-15 W. 60 feet to the point of beginning.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
