MORTGAGE OF REAL ESTATE

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No.26 of a subdivision known as Shamrock Acres as shown on a plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book YY at Page 43, and has such metes and bounds as shown thereon.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.
