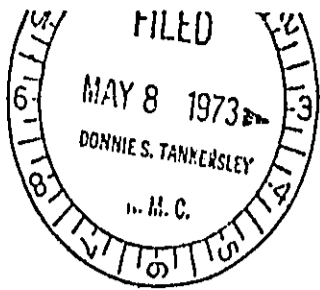

Consolidated Credit Corp. of Anderson, the following described property being real estate situate in the County of Greenville, State of South Carolina:

All that certain lot of land lying in Gantt Township, Greenville County, State of South Carolina on the Southern side of Apple Drive, being shown and designated as Lot No. 9 on plat of Apple Blossom Terrace, recorded in Plat Book GG at page 192 in the M. M. C. Office for Greenville County and having according to said plat the following metes and bounds to wit:

BEGINNING at an iron pin on the southern side of Apple Drive, at the joint front corner of Lot Nos. 9 and 10, and running thence along the southern side of Apple Drive, S. 88-00 W. 100 feet to pin at corner of Lot No. 8; thence with the line of Lot No. 8, S. 2-00 E. 150 feet to pin; thence N. 88-00 E. 100 feet to pin at the rear corner of Lot No. 10; thence with the line of Lot No. 10, N. 2-00 W. 150 feet to the point of beginning.
