| readvance to him sums paid on the said note and mortgage and/or to extend the time for the performance of the obligation. |
| NOW THEREFORE: |
| IA. The Association agrees to extend the time for payment of the principal indebtedness of \$.2,500.00 |
| now remaining unpaid so that it shall be payable as follows: \$ 50.40 on the FIRST DAY of MAY on the FIRST DAY of each month |
| thereafter until paid in full, said payments to be applied first to interest, calculated monthly at the rate of 7/4/6 per annum, or in accordance with those terms agreed upon in the mortgage note and/or the Modification and Assumption Agreement, where applicable, on the unpaid balance and the remainder on principal until paid in full; or |
| 1B. In consideration of the readvance and extension to the Obligor of the sum of \$ 2,500.00 and the extension of the time for performance, the Obligor agrees that the rate of interest on the entire amount now due, |
| including the readvance, be increased to 12/4 per cent per annum, and those terms expressly agreed upon in the mortgage note and/or in the Modification and Assumption Agreement, be in effect, and the Obligor does hereby agree |
| that the said readvance and extension was advanced by the Association for the account of the Obligor and that the said sum shall be secured by the said note and mortgage. All terms and conditions of the Mortgage Note and/or the Modification and Assumption Agreement shall continue in full force except as modified expressly by this agreement and the statute of limitations will not commence to run against the obligation until the expiration of the time for payment of the indebtedness as herein extended. |
| 4. This agreement shall bind jointly and severally the heirs, the executors, the administrators, the successors and the assigns of the Association and of the Obligor respectively. |
