to The Federal Land Bank of Columbia, dated the 3rd day of February, 1970, and recorded in the public records of Greenville County, State of South Carolina in Mortgage Book 1147, at page 411, the following described property, to-wit:

ALL that certain piece, parcel or lot of land situate, lying and being in Bates Township, Greenville County, State of South Carolina, containing One and Eighty Three One-Hundredths (1.83) acres, more or less, and being bounded on the North by dirt road, on the South and East by other lands of Dennis L. Collins, and on the West by dirt road. This being more particularly described on plat of survey by Terry T. Dill, Reg. L.S. No.104 and dated February 28, 1972.
