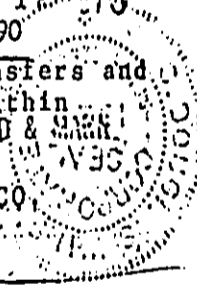
The Mortgagor covenants and agrees as follows:
