

IN THE STATE AFORESAID—SEND GREETING:

WHEREAS we the said Richard S. and Lillian Copeland

(Hereinafter also styled the

All that lot of land in the city of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot #2 and a small portion of Lots #7 and one plot of Rachel J. Coly recorded in Plot Book #2, page #15 of the R. I. C. Office for Greenville County, South Carolina and having according to said plot and a recent survey made by R. H. Dalton, the following notes and bounds.....

Beginning at an iron pin on the southeast side of Ackley Street, the joint front corner of lots #2 and #3, thence with the joint line of said lots S. 23-1/2 E. 220.1 feet to an iron pin, thence S. 51-03 W. 141.3 feet to an iron pin corner of lots #2, thence with the line of said lots S. 36-06 E. 9.5 feet to an iron pin thence S. 51-03 W. 50 feet to an iron pin thence S. 36-06 W. with the line of lots #5 and #3 E. 26-33 W. 252.3 feet to an iron pin on the southeast side of Ackley Street, thence with the Southeast side of said street E. 65-15 W. 170 feet to the beginning corner
