

MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate lying and being in the State of South Carolina, County of Greenville, at the southeastern corner of the intersection of Gilder Creek Drive with Hamby Drive in the Town of Mauldin, Greenville County, South Carolina being shown and designated as Lot No. 157 on a plat of Forrester Woods, Section III, made by R. B. Bruce, Surveyor dated August 22, 1972 recorded in the RMC Office for Greenville County, S. C. in Plat Book 4-R, page 51 and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Gilder Creek Drive at the common corner of Lots Nos. 156 and 157 and running thence with the common line of said lots, S. 45-43 E. 125 feet to an iron pin; thence N. 27-04 E. 175 feet to an iron pin on Hamby Drive; thence along the southwestern side of Hamby Drive, N. 45-43 W. 100 feet to an iron pin; thence with the curve of the intersection of Hamby Drive with Gilder Creek Drive, the chord of which is S. 80-40 W. 29.7 feet to an iron pin 29.7 feet to an iron pin; thence along the eastern side of Gilder Creek Drive, S. 27-04 W. 150 feet to an iron pin, the beginning corner.
