WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty-five Thousand Two Hundred and no/100ths----- DOLLARS

(\$ 25,200.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 25 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Delmar Drive, in the Town of Simpsonville, being shown and designated as Lot No. 33 on a plat of BRENTWOOD, SECTION 2, made by Piedmont Engineers and Architects, Surveyors, dated May 19th, 1972, recorded in the RMC Office for Greenville County, S. C., in Plat Book 4-R, page 5, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Delmar Drive at the joint front corners of Lots Nos. 33 and 34, and running thence along the common line of said lots, S. 54-00 W., 150 feet to an iron pin; thence along the rear lines of Lots Nos. 27 and 28, S. 36-00 E., 105 feet to an iron pin at the joint rear corners of Lots Nos. 32 and 33; thence along the common line of said lots, N. 54-00 E., 150 feet to an iron pin on Delmar Drive; thence along the western side of Delmar Drive, N. 36-00 W., 105 feet to an iron pin, the beginning corner.
