"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northwestern side of Randy Drive and being known and designated as Lot No. 87 on a plat of EDWARDS FOREST Subdivision, Section 2, plat of which is recorded in the RMC Office for Greenville County in Plat Book "RR" at Page 20, and having, according to said plat, the following metes and bounds, to-wit:
