TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Colin Curtis Kemp

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto WOODRUFF FEDERAL SAVINGS AND LOAN ASSOCIATION, (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of TWENTY-TWO THOUSAND and no/100--- DOLLARS (\$ 22,000.00), with interest thereon from date at the rate as specified in said note, said principal and interest to be repaid as therein stated, said note provides that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of May 1998, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated on plat prepared for A. B. Kemp by H. S. Brockman, R. S. June 25, 1934 and revised June 11, 1971 by W. N. Willis, Eng. and according to said plat contains 2.7 acres, more or less, being described as follows: Beginning at an iron pin on the bank of S. C. Highway #14 and running thence S.78-12 E.129 feet to an iron pin, thence S.54-30 E.307 feet to an iron pin, thence S.29-40 W.235 feet to an iron pin, thence N. 60-37 W.520 feet to an iron pin on bank of South Carolina Highway #14, thence with the Southeast side of said highway N.51-35 E.249 feet to the point of beginning. This being the same property which was conveyed to mortgagor herein by A. B. Kemp by deed recorded in the R. M. C. Office for said County in Deed Book 933, page 159. For a more particular description see the aforesaid revised plat which will be recorded forthwith in the said office.
