WHEREAS: Raymond E. Baker

Taylor, South Carolina, hereinafter called the Mortgagor, is indebted to

, a corporation  
organized and existing under the laws of South Carolina, hereinafter  
called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incor-  
porated herein by reference, in the principal sum of Twenty-Four Thousand Two Hundred Fifty  
and no/100----- Dollars (\$ 24,250.00 ), with interest from date at the rate of  
seven per centum ( 7 % ) per annum until paid, said principal and interest being payable  
at the office of C. DOUGLAS WILSON & CO.  
in Greenville, South Carolina, or at such other place as the holder of the note may  
designate in writing delivered or mailed to the Mortgagor, in monthly installments of One Hundred Sixty-  
One and 51/100----- Dollars (\$ 161.51 ), commencing on the first day of  
August, 1973, and continuing on the first day of each month thereafter until the principal and  
interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and  
payable on the first day of July, 2003.

payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor

whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does  
grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described  
property situated in the county of Greenville  
State of South Carolina; near the City of Greenville, being known and designated  
as Lot 234, on Plat of Colonial Hills, Section 6, which plat is recorded  
in the RMC Office for Greenville County, South Carolina, Plat Book WWW,  
at Pages 12 and 13.

The following items are hereby acknowledged as part of the mortgaged
