## MORTGAGE

25 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southeast side of Rollingreen Road being shown as Lot 252, Sector V, Botany Woods, which plat of same is recorded in the RMC Office for Greenville, S. C. in Plat Book YY, Pages 6 and 7 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeast side of Rollingreen Road at the joint corner of Lots 252 and 253 and runs thence along the southeast side of Rollingreen Road N. 52-12 E. 109.5 feet to an iron pin; thence with the curve of said road (the chord being N. 77-50 E. 46.8 feet) to an iron pin; thence along the line of Lot 251 S. 1-50 E. 186.7 feet to an iron pin at the corner of Lot 254; thence with the line of Lot 254 N. 86-05 W. 43.3 feet to an iron pin at the corner of Lot 253; thence with the line of Lot 253 N. 37-48 W. 135 feet to the beginning corner.
