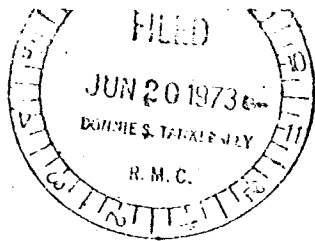

All that certain Pieces, parcel or lot of land situate, lying and being in Greenville
County, South Carolina, being shown and described as a portion of Lot 21, "Highview Acres"
on a plot of "Property of Marvin S. Stone & Mary Ann Stone", Greenville, County., S.C.
dated June 24th, 1972 and recorded in the RMC Office for Greenville, County, South Carolina
in Plat 4-Q at Page 138 and according to said plat having the following metes and bounds,
to wit,:

Begining at an iron pin on the following western side of Courtland Drive being the joint
front corner of Lots 21 and 22; running thence N. 84-30W., 400 feet to an Iron
Pin being the joint rear corner of Lots 21 and 22, thence runnign S. 84-30 E. 229.5 feet
