Domestic Loans of Greenville, Inc., S.C.

All that piece, parcel or lot of land, situate in the County of Greenville, State of South Carolina, situate, lying and being on the Western side of Brook Forest Drive, being known and designated at Lot No. 11, as shown on a plat of section 2, Belle Meade, made by Piedmont Engineering Services, June 1954, and recorded in the R.M.C. Office for Greenville County in Plat Book EE, at pages 116 and 117, and having, according to said Plat, the following Metes and Bounds; to wit:

Beginning at an iron pin on the Western side of Brook Forest Drive, said pin being 70 feet from the Southwestern intersection of Brook Forest Drive and Williamsburg Drive; thence S. 36-53 W. 154.5 feet to an iron pin; thence S. 50-40 E. 80.45 feet to an iron pin; thence N. 38-20 E. 160 feet to an iron pin on the the Western side of Brook Forest Drive; thence N 54-49 W. 85 feet to the point of beginning.

This conveyance is made subject to such easements, rights-of-way and restrictions of record or as appear on the premises.
