## MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

W. N. Leslie, Inc. -----(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Thirty-six Thousand Four Hundred and No/100 -----

DOLLARS (\$ 36,400.00 -----), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable, February 1, 1999 -----

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being

ALL that piece, parcel or lot of land situate, lying and being on the southern corner of the intersection of Wallingford Road and Broms Grove Drive near the City of Greenville, in the County of Greenville, State of South Carolina and known and designated as Lot No. 5 of a subdivision known as Buxton, plat of which is recorded in the R.M.C. Office for Greenville County in Plat Book 4N at Pages 2 through 4 and according to said plat has the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Wallingford Road at the joint corner of Lots Nos. 4 and 5 and running thence along Wallingford Road N. 28-06 E., 95 feet to an iron pin in the curve of the intersection of Wallingford Road and Broms Grove Drive and running thence with the curve of said intersection N. 70-34 E., 36.9 feet to an iron pin on Broms Grove Drive; running thence with Broms Grove Drive S. 67-00 E., 125 feet to an iron pin at the joint corner of Lots Nos. 5 and 6; running thence with the joint line of said lots S. 24-15 W., 133.4 feet to an iron pin at the joint rear corner of Lots Nos. 4, 5 and 6; running thence with the joint line of Lots Nos. 4 and 5, N. 59-05 W., 158.55 feet to an iron pin, point of beginning..
